CARRIED OVER FROM THE 04/02/2013 AGENDA: FIRST PUBLIC HEARING: Revises requirement that contracting agency dedicate certain amount of contract price toward including green energy technology in public building.

#### Work Session

HB 2662

CARRIED OVER FROM THE 04/02/2013 AGENDA: Prohibits owner of foreclosed residential real property from neglecting foreclosed residential real property during period of vacancy.

HB 2207

CARRIED OVER FROM THE 04/02/2013 AGENDA: Requires payment of state payroll to be made through direct electronic deposit.

HB 2536

CARRIED OVER FROM THE 04/02/2013 AGENDA: Modifies laws relating to transfers of structured settlement payment rights.

HB 2824

CARRIED OVER FROM THE 04/02/2013 AGENDA: Clarifies that tower does not need to contact owner of parking facility or owner's agent at time of tow before towing motor vehicle from facility if sign warning that parking is prohibited is posted or if motor vehicle is parked next to red or yellow curb.

HB 3159

CARRIED OVER FROM THE 04/02/2013 AGENDA: Directs Oregon Transportation Commission to set maximum rates for towing and related services when tower tows motor vehicle without consent or authorization of owner or operator.

HB 2978

Sets out uniform provisions for certain aspects of state building code administration and enforcement.

#### **Public Hearing**

HB 3357

FIRST PUBLIC HEARING: Creates disclosure requirements related to use of refund anticipation payment instruments by tax consultants and tax preparers.

HB 3415

FIRST PUBLIC HEARING: Requires public body acting as radio common carrier to charge market rate for access to radio tower for delivery of radio communications service, radio paging or cellular communications service for hii

HB 3447

FIRST PUBLIC HEARING: Requires person that conducts floral business operation to disclose physical location of person's principal place of business in advertisements for floral business operation.

#### **Work Session**

HB 2429

Requires that public bodies develop and implement policies for securely removing personal information from digital data storage devices and other electronic data storage devices before selling, donating, recycling or otherwise disposing of device.

HB 2821

Modifies amount of reimbursement due personal injury protection provider when total benefits exceed damages.

HB 2822

Disallows publication of notice of sale of real property by Internet posting without additional publication in newspaper of general circulation.

HB 2823

Specifies individuals who may control association accounts of planned community or condominium.

HB 2929

Provides penalty of \$500 for trustee's failure to give notice of trustee's sale postponement in accordance with requirements.
