HB 2822

CARRIED OVER FROM THE 4/9/2013 AGENDA: Disallows publication of notice of sale of real property by Internet posting without additional publication in newspaper of general circulation.

HB 3400

HB 2927 **

**Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 4/9/2013 AGENDA: Establishes Task Force on State Government Boards and Commissions.

HB 3168

CARRIED OVER FROM THE 4/9/2013 AGENDA: Requires Oregon Department of Administrative Services to adopt rules for purposes of establishing statewide criteria by which certain qualified entities and authorized agencies conduct criminal records checks for purposes other than criminal justice.

HB 3172

CARRIED OVER FROM THE 4/9/2013 AGENDA: Requires seller of real property to obtain septic system evaluation report and provide copies to Department of Environmental Quality and to each buyer that makes written offer to purchase.

HB 3415

CARRIED OVER FROM THE 4/9/2013 AGENDA: Requires public body acting as radio common carrier to charge market rate for access to radio tower for delivery of radio communications service, radio paging or cellular communications service for hire.

HB 2823

Specifies individuals who may control association accounts of planned community or condominium.

HB 3447

Requires person that conducts floral business operation to disclose physical location of person's principal place of business in advertisements for floral business operation.

HB 3013

Excludes real estate appraisals submitted to housing authority or obtained by Housing and Community Services Department from public records disclosure exemption.

HB 3159

Directs Oregon Transportation Commission to set maximum rates for towing and related services when tower tows motor vehicle without consent or authorization of owner or operator.

HB 2295 **

Appropriates moneys to Oregon Progress Board for purposes of performing functions of board.

HB 2620 **

**Subsequent Referral(s) to Ways and Means

Directs Governor to develop reorganization plan for economic development agencies, community development and services agencies and natural resource agencies necessary to implement regional and community based governance.

HB 3329 **

**Subsequent Referral(s) to Ways and Means

Establishes State Data Center Board and prescribes board's duties.

HB 3174

Allows Oregon resident filing for bankruptcy to either claim exemptions established by federal law or claim exemptions established by state law.

HB 3258 **

**Subsequent Referral(s) to Ways and Means

Establishes office of State Chief Information Officer for purpose of directing policy and coordinating state government and state agencies in planning for, acquiring, installing and using telecommunications and information technology.

HB 3330 **

**Subsequent Referral(s) to Ways and Means

Requires use of electronic fingerprint capture technology for purposes of conducting criminal records checks not related to administration of criminal justice system.

HB 3331 **

**Subsequent Referral(s) to Ways and Means

Directs Department of State Police to establish Voluntary Central Criminal Records Check Registry.

HB 3360 **

**Subsequent Referral(s) to Ways and Means

Establishes Task Force on State Agency Information Technology Expertise for purpose of investigating extent to which creating division or other administrative unit within state agency and employing information technology specialists to meet common and critical information technology needs among state agencies is practical and feasible and to determine costs and benefits of employing information technology specialists within state agencies compared costs and benefits of contracting for

HB 3409

Specifies that natural hair care is not barbering or hair design for purposes of regulating cosmetology.
