**Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 04/11/2013 AGENDA: Makes legislative findings regarding merits of state agency administration and enforcement of state building code for capital construction projects receiving state-supplied funding.

HB 3400

CARRIED OVER FROM THE 04/11/2013 AGENDA: Directs Governor's budget report submitted to Legislative Assembly to describe, for each state agency, percentage of expenditures made in Oregon by agency under contracts for goods or services.

HB 3172

CARRIED OVER FROM THE 04/11/2013 AGENDA: Requires seller of real property to obtain septic system evaluation report and provide copies to Department of Environmental Quality and to each buyer that makes written offer to purchase.

HB 3415

CARRIED OVER FROM THE 04/11/2013 AGENDA: Requires public body acting as radio common carrier to charge market rate for access to radio tower for delivery of radio communications service, radio paging or cellular communications service for hire.

HB 3447

CARRIED OVER FROM THE 04/11/2013 AGENDA: Requires person that conducts floral business operation to disclose physical location of person's principal place of business in advertisements for floral business operation.

HB 3013

CARRIED OVER FROM THE 04/11/2013 AGENDA: Excludes real estate appraisals submitted to housing authority or obtained by Housing and Community Services Department from public records disclosure exemption.

HB 3174

CARRIED OVER FROM THE 04/11/2013 AGENDA: Allows Oregon resident filing for bankruptcy to either claim exemptions established by federal law or claim exemptions established by state law.

HB 3360 **

**Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 04/11/2013 AGENDA: Establishes Task Force on State Agency Information Technology Expertise for purpose of investigating extent to which creating division or other administrative unit within state agency and employing information technology specialists to meet common and critical information technology needs among state agencies is practical and feasible and to determine costs and benefits of employing information technology specialists within state agencies compared to costs and benefits of contracting for

HB 3159

CARRIED OVER FROM THE 04/11/2013 AGENDA: Directs Oregon Transportation Commission to set maximum rates for towing and related services when tower tows motor vehicle without consent or authorization of owner or operator.

Public Hearing and Work Session

HB 3485

FIRST PUBLIC HEARING: Prohibits person from sending advertisement that is for mortgage loan services or othe extensions of credit that are secured by real property and that has certain characteristics unless person has previous business relationship with recipient or unless advertisement meets certain criteria.

HB 3486

FIRST PUBLIC HEARING: Exempts from disclosure under public records law audio recording of voice of caller to 9-1-1 emergency reporting system unless public interest requires disclosure.

HB 3489

FIRST PUBLIC HEARING: Limits escrow agent's exemption from licensing requirements in instances where escrow agent provides debt management services, money transmission services or services to debt management service providers that must be licensed.

HB 3493

FIRST PUBLIC HEARING: Exempts from disclosure voter registration records of individuals less than 18 years of age as of date of request for disclosure.

HJM 12

FIRST PUBLIC HEARING: Urges Congress and Federal Communications Commission to support and protect right-of-way management and compensation authority of local governments.

HB 3116 **

**Subsequent Referral(s) to Ways and Means

FIRST PUBLIC HEARING: Removes Oregon University System's exemption from Public Contracting Code.

HB 3004

FIRST PUBLIC HEARING: Requires certain management service employees to elect to remain in position or return to position in classified service within one year of entering management service.

HB 3165 **

**Subsequent Referral(s) to Ways and Means
FIRST PUBLIC HEARING: Specifies circumstances under which Director of Oregon Department of
Administrative Services may grant exception to requirement that state agencies achieve ratio of at least 11 to 1 of
nonsupervisory employees to supervisory employees.

HB 3389

FIRST PUBLIC HEARING: Requires beneficiary under residential trust deed to request resolution conference with grantor for purposes of negotiating foreclosure avoidance measure, unless beneficiary is eligible to claim exemption from requirement.

Requires school districts and community college districts to include certain information on Oregon transparency website.

HB 2955 ** **Subsequent Referral(s) to Ways and Means

Permits employee of contracting agency that conducts cost analysis or determines feasibility of procurement to seek judicial review of cost analysis or determination.

HB 3169 **

**Subsequent Referral(s) to Ways and Means

Pavises requirement that contracting agency dedicate certain amount of contract price toward including green energy.

Revises requirement that contracting agency dedicate certain amount of contract price toward including green energ technology in public building.

HB 2429

Requires that public bodies develop and implement policies for securely removing personal information from digita data storage devices and other electronic data storage devices before selling, donating, recycling or otherwise disposing of device.

HB 2826

Establishes requirements under which debt buyer may bring legal action to collect debt.

HB 2536

Modifies laws relating to transfers of structured settlement payment rights.

HB 2662

Prohibits owner of foreclosed residential real property from neglecting foreclosed residential real property during period of vacancy.

HB 2828 **

**Subsequent Referral(s) to Ways and Means

Requires Department of State Police to establish program through which department retains fingerprint cards or creates facsimiles of fingerprints received from Federal Bureau of Investigation or created during state criminal records check for purpose of notifying authorized agencies or districts that subscribe to program of receipt of fingerprints or other identifying information by department for purposes related to administration of criminal justice

HB 3328

Removes Oregon Department of Administrative Services as exclusive authority for procuring or providing information technology, telephone and telecommunications services for state agencies.
