- HB 2424 ** **Subsequent Referral(s) to Revenue
FIRST PUBLIC HEARING: Changes exclusion from local revenues for purposes of State School Fund distribution and local option equalization grants.
- HB 2494 ** **Subsequent Referral(s) to Revenue
FIRST PUBLIC HEARING: Directs Department of Education to conduct evaluation of weights used for distribution of State School Fund.
- HB 2500 ** **Subsequent Referral(s) to Revenue then to Ways and Means

FIRST PUBLIC HEARING: Provides funding for instruction for talented and gifted children based on amount per student.
- HB 2098 ** **Subsequent Referral(s) to Revenue
FIRST PUBLIC HEARING: Adjusts method for calculating additional amount of weighted average daily membership attributed to students in poverty families for purposes of State School Fund distributions.
