- HB 2435 ** **Subsequent Referral(s) to Revenue
Exempts from fuel excise tax diesel fuel blended with minimum 20 percent biodiesel derived from used cooking oil
- HB 2516 ** **Subsequent Referral(s) to Ways and Means
Allows moneys in Watershed Conservation Operating Fund and Watershed Conservation Grant Fund to be used for educating elementary school students concerning protection and restoration of native fish or wildlife habitats, watersheds or ecosystems.
- HB 2694
Requires Department of State Lands to study certain issues related to development of energy resources in Oregon's territorial sea.

- HB 2792 ** **Subsequent Referral(s) to Revenue then to Ways and Means
FIRST PUBLIC HEARING - Imposes tax on each fuel supplier and utility based on amount of carbon in carbon-based fuel that is sold by fuel supplier to consumers in state or that is used to produce carbon-generated electricity supplied by utility to consumers in state.
- HB 2048 ** **Subsequent Referral(s) to Ways and Means
FIRST PUBLIC HEARING - Repeals sunset on architectural paint stewardship program.

Public Hearing and Work Session

- HB 3448
FIRST PUBLIC HEARING Exempts diesel fuel sold to facilities that store more than 50 gallons of fuel for use in emergency power generation from requirement to contain certain percentage of biodiesel or to contain other diesel with specified percentage of renewable component.
