HB 2724

CARRIED OVER FROM THE 2/27/2013 AGENDA: FIRST PUBLIC HEARING: Exempts retainer dental practice from application of Insurance Code if certified by Department of Consumer and Business Services.

HB 2691

Authorizes nonresident physicians and nurses licensed and in good standing in another state to provide volunteer services related to practice of medicine or nursing in this state under specified circumstances.
