Possible Introduction of Committee Measures

- HB 2104
Revises definition of "medical imaging" to include medical imaging procedures not related to clinical diagnosis and treatment.
- HB 2522
Requires coordinated care organization to provide members with access to chiropractic, naturopathic and nurse practitioner services for primary care and access to licensed acupuncturists, licensed massage therapists and licensed optometrists for specialty care and to pay same reimbursement rate for service to all providers of service, regardless of license or certification of provider.
- HB 2902
Requires insurers to reimburse physician assistants and nurse practitioners at same rate as physicians for same services.

Public Hearing and Possible Work Session

- HB 2858 ** **Subsequent Referral(s) to Ways and Means
FIRST PUBLIC HEARING: Appropriates money to Oregon Department of Administrative Services for deposit in Primary Health Care Loan Forgiveness Program Fund.
- HB 2065
FIRST PUBLIC HEARING: Creates process through which licensee or applicant to practice dentistry may petition Oregon Board of Dentistry to expunge from board records information related to disciplinary hearings.
- SCR 1
Supports adoption of State Plan for Alzheimer's Disease and Related Dementias in Oregon.
- HB 2216 ** **Subsequent Referral(s) to Revenue
FIRST PUBLIC HEARING: Repeals sunset on collection of hospital assessment.
