CARRIED OVER FROM 3/11/2013 AGENDA: Requires insurers to reimburse physician assistants and nurse practitioners at same rate as physicians for same services.

FIRST PUBLIC HEARING: Requires insurer that provides coverage of ambulance care and transportation to indemnify provider of ambulance care and transportation directly.
