HB 2611

Directs certain health professional regulatory boards to adopt rules by January 1, 2017, requiring licensees to document participation in continuing education opportunities relating to cultural competency approved by Oregon Health Authority.

HB 3082 **

**Subsequent Referral(s) to Ways and Means

FIRST PUBLIC HEARING: Requires State Board of Education to adopt rules requiring provision of fluoride rinse to certain students and children after certain meals.

HB 3378 **

**Subsequent Referral(s) to Ways and Means

FIRST PUBLIC HEARING: Requires health benefit plans provided by Public Employees' Benefit Board and Oregon Educators Benefit Board to provide telemedicine services to eligible employees.

HB 2385

FIRST PUBLIC HEARING: Removes, from health insurance coverage requirements for chemical dependency and mental or nervous conditions, exemption for treatment resulting from conviction of driving while under influence of intoxicants.

HCR 17

FIRST PUBLIC HEARING: Declares commitment of Legislative Assembly to making lung cancer awareness public health priority.

Makes changes to educational and training qualifications necessary to be licensed to practice psychology.
