#### Work Session

HB 2611

CARRIED OVER FROM THE 4/1/2013 AGENDA: Directs certain health professional regulatory boards to adopt rules by January 1, 2017, requiring licensees to document participation in continuing education opportunities relating to cultural competency approved by Oregon Health Authority.

HB 2090

Repeals operative date provision to require Oregon Health Authority to continue to use Practitioner-Managed Prescription Drug Plan for prescription drug coverage in medical assistance program on and after January 2, 2014.

HB 2137

Requires Oregon Health Authority to establish system for repurposing durable medical equipment that is no longer medically appropriate for medical assistance recipients for use by other medical assistance recipients.

HB 2076

Requires covered entities to report annually on system safeguards for protecting confidentiality of individually identifiable health information.

HCR 16

Recognizes addiction as disease.

#### Public Hearing and Possible Work Session

HB 2928

FIRST PUBLIC HEARING: Modifies definition of "hazardous substance." Requires Director of Oregon Health Authority to adopt standards for labeling of articles that contain hazardous substances.

HB 3466

FIRST PUBLIC HEARING: Authorizes pharmacist to initiate or modify drug therapy in accordance with guideline and protocols established by physician licensed to practice medicine.
