#### Work Session

- HB 2090  
CARRIED OVER FROM THE 4/3/2013 AGENDA: Repeals operative date provision to require Oregon Health Authority to continue to use Practitioner-Managed Prescription Drug Plan for prescription drug coverage in medical assistance program on and after January 2, 2014.
- HB 2076  
CARRIED OVER FROM THE 4/3/2013 AGENDA: Requires covered entities to report annually on system safeguards for protecting confidentiality of individually identifiable health information.
- HB 2432  
Prohibits cost-sharing for health services, medications and supplies medically necessary for management of diabetes during pregnancy and for six weeks postpartum.
- HB 2128  
Requires Oregon Health Insurance Exchange Corporation and Oregon Educators Benefit Board to reach agreement plans offered through exchange to educators.

#### Public Hearing and Possible Work Session

- HB 3407 \*\* \*\*Subsequent Referral(s) to Ways and Means  
FIRST PUBLIC HEARING: Establishes Traditional Health Workers Commission within Oregon Health Authority to adopt by rule criteria and descriptions for coordinated care organizations to use with respect to health workers who are not licensed by this state and training and education requirements for those workers.
- HB 3403  
FIRST PUBLIC HEARING: Establishes nutritional requirements for food and beverage items sold in public buildings.
- HB 2348 \*\* \*\*Subsequent Referral(s) to Ways and Means  
FIRST PUBLIC HEARING: Establishes eight regional public health authorities.

#### Public Hearing

- HB 3260 \*\* \*\*Subsequent Referral(s) to Ways and Means  
FIRST PUBLIC HEARING: Requires Oregon Health Authority to conduct study or contract with third party to study and recommend best option for financing health care in state.
