HB 2432

Prohibits cost-sharing for health services, medications and supplies medically necessary for management of diabetes during pregnancy and for six weeks postpartum.

HB 2128

Requires Oregon Health Insurance Exchange Corporation and Oregon Educators Benefit Board to reach agreement plans offered through exchange to educators.
