HJM 14

FIRST PUBLIC HEARING: Urges Congress to enact legislation permitting negotiation of drug prices and rebates on behalf of Medicare recipients.

HB 2353

FIRST PUBLIC HEARING: Requires health insurer to report to Director of Department of Consumer and Business Services methodology for reimbursement of clinical social workers.

HB 2087

FIRST PUBLIC HEARING: Requires Oregon Health Authority to submit written report on legislative changes that will need to be made during 2015 regular session of Legislative Assembly to align state law with federal laws concerning health care delivery.

HB 2073 **

FIRST PUBLIC HEARING: Repeals sunset on assessment on health insurance premiums and on medical claims paid by self-insured health benefit plan offered by Public Employees' Benefit Board.

HB 3496 **

FIRST PUBLIC HEARING: Transfers duties, functions and powers relating to issuance of authorizations and enforcement and certain other duties, functions and powers, from State Board of Psychologist Examiners, Occupational Therapy Licensing Board, State Board of Licensed Social Workers, Oregon Board of Licensed Professional Counselors and Therapists, State Board of Examiners for Speech-Language Pathology and Audiology, State Board of Chiropractic Examiners, Oregon Board of Naturopathic Medicine

HB 2997 **

Requires person to obtain license to practice direct entry midwifery.

**Subsequent Referral(s) to Ways and Means

HB 2122

Prohibits transfer of provider's enrollees from one managed care organization to another managed care organization with which provider contracts if provider's contract with transferring organization is terminated for cause.

HB 2724

Exempts retainer dental practice from application of Insurance Code if certified by Department of Consumer and Business Services.
