HB 2118

CARRIED OVER FROM THE 4/12/2013 AGENDA: Specifies additional criteria for certifying health plans to participate in Oregon Health Insurance Exchange.

HB 2122

CARRIED OVER FROM THE 4/12/2013 AGENDA: Prohibits transfer of provider's enrollees from one managed care organization to another managed care organization with which provider contracts if provider's contract with transferring organization is terminated for cause.

HB 2132

CARRIED OVER FROM THE 4/12/2013 AGENDA: Requires Oregon Health Authority to take specified steps to enroll in qualified health plan person who loses eligibility for medical assistance.

- HB 3162 ** **Subsequent Referral(s) to Ways and Means CARRIED OVER FROM THE 4/12/2013 AGENDA: Requires Oregon Health Authority to maintain list of designated high priority chemicals of concern for children's health used in children's products.
- HB 3407 ** **Subsequent Referral(s) to Ways and Means CARRIED OVER FROM THE 4/12/2013 AGENDA: Establishes Traditional Health Workers Commission within Oregon Health Authority to adopt by rule criteria and descriptions for coordinated care organizations to use with respect to health workers who are not licensed by this state and training and education requirements for those workers.
- HB 2279 **

**Subsequent Referral(s) to Ways and Means

Allows employees of local governments to participate in benefit plans provided by Public Employees' Benefit Board and Oregon Educators Benefit Board.

- HB 3082 ** **Subsequent Referral(s) to Ways and Means Requires State Board of Education to adopt rules requiring provision of fluoride rinse to certain students and childre after certain meals.
- HB 2445 **

**Subsequent Referral(s) to Ways and Means

Requires Oregon Health Authority to reimburse school-based health centers on fee-for-service basis for services provided to students who qualify for medical assistance if center is not part of coordinated care organization and is not patient centered primary care home.

HB 2136 **

**Subsequent Referral(s) to Ways and Means

Directs that moneys received under Master Settlement Agreement be distributed to Oregon Health Authority Fund and to Tobacco Use Reduction Account.

- HB 3403
 - Establishes nutritional requirements for food and beverage items sold in public buildings.

HB 2928

Modifies definition of "hazardous substance." Requires Director of Oregon Health Authority to adopt standards for labeling of articles that contain hazardous substances.

HB 2085

CARRIED OVER FROM THE 4/12/2013 AGENDA: Requires Oregon Health Authority to submit written report on legislative changes that will need to be made during 2015 regular session of Legislative Assembly to align state law with federal laws concerning public health and publicly funded health programs.

HB 2088

CARRIED OVER FROM THE 4/12/2013 AGENDA: Requires Oregon Health Authority to submit written report on legislative changes that will need to be made during 2015 regular session of Legislative Assembly to reflect budgetary changes.

HB 3345

CARRIED OVER FROM THE 4/12/2013 AGENDA: Provides for regulation of persons that engage in recovery or distribution of anatomical material from donors.

HB 2960

FIRST PUBLIC HEARING: Expands definition of "public body" subject to public meetings law to include coordinated care organizations.

HB 2037 A

Requires, under specified circumstances, certain professional regulatory boards to issue authorization to practice profession to spouse or domestic partner of active member of Armed Forces who is subject of military transfer to Oregon.
