#### Public Hearing and Possible Work Session

HB 2065

Creates process through which licensee or applicant to practice dentistry may petition Oregon Board of Dentistry to expunge from board records information related to disciplinary hearings.

HB 2073 \*\*

\*\*Subsequent Referral(s) to Revenue

FIRST PUBLIC HEARING: Repeals sunset on assessment on health insurance premiums and on medical claims paid by self-insured health benefit plan offered by Public Employees' Benefit Board.

HB 2118

CARRIED OVER FROM THE 4/15/2013 AGENDA: Specifies additional criteria for certifying health plans to participate in Oregon Health Insurance Exchange.

HB 2132

CARRIED OVER FROM THE 4/15/2013 AGENDA: Requires Oregon Health Authority to take specified steps to enroll in qualified health plan person who loses eligibility for medical assistance.

HB 2122

CARRIED OVER FROM THE 4/15/2013 AGENDA: Prohibits transfer of provider's enrollees from one managed care organization to another managed care organization with which provider contracts if provider's contract with transferring organization is terminated for cause.

HB 3403

CARRIED OVER FROM THE 4/15/2013 AGENDA: Establishes nutritional requirements for food and beverage items sold in public buildings.

HB 2928

CARRIED OVER FROM THE 4/15/2013 AGENDA: Modifies definition of "hazardous substance." Requires Director of Oregon Health Authority to adopt standards for labeling of articles that contain hazardous substances.

HB 3345

CARRIED OVER FROM THE 4/15/2013 AGENDA: Provides for regulation of persons that engage in recovery or distribution of anatomical material from donors.

- HB 3082 \*\* \*\*Subsequent Referral(s) to Ways and Means  
CARRIED OVER FROM THE 4/15/2013 AGENDA: Requires State Board of Education to adopt rules requiring provision of fluoride rinse to certain students and children after certain meals.
- HB 2085  
CARRIED OVER FROM THE 4/15/2013 AGENDA: Requires Oregon Health Authority to submit written report on legislative changes that will need to be made during 2015 regular session of Legislative Assembly to align state law with federal laws concerning public health and publicly funded health programs.
- HB 2960  
CARRIED OVER FROM THE 4/15/2013 AGENDA: Expands definition of "public body" subject to public meetings law to include coordinated care organizations.
- HB 3460  
Directs Oregon Health Authority to establish registration system for medical marijuana facilities for transferring usable marijuana from registry identification cardholders, designated primary caregivers of registry identification cardholders or marijuana grow sites to medical marijuana facilities and from medical marijuana facilities to registry identification cardholders or designated primary caregivers of registry identification cardholders.
