#### Public Hearing

HB 3430

FIRST PUBLIC HEARING: Directs Oregon Health Authority to adopt rules requiring physician or midwife to inform mother or father after birth of child about benefits of testing infants for Krabbe disease.

#### Public Hearing and Possible Work Session

SB 107 A

Modifies certain provisions relating to Nursing Home Administrators Board, Respiratory Therapist and Polysomnographic Technologist Licensing Board, Board of Cosmetology, Board of Body Art Practitioners and Oregon Health Licensing Agency.

SB 109

Authorizes designees of Oregon Board of Naturopathic Medicine to issue subpoenas for purpose of investigating alleged violations of laws relating to naturopathic medicine.

SB 210

Authorizes certified registered nurse anesthetists to deliver certain services without medical collaboration in connection with procedures performed in location at which medical, surgical or dental services are rendered, other than ambulatory surgical center or hospital.

SB 284 A

Directs Oregon Health Authority to conduct study on feasibility of requiring all infants born in this state to be screened for lysosomal storage disorders.
