#### Work Session

SB 491

CARRIED OVER FROM THE 5/6/2013 AGENDA: Permits minor 14 years of age or older to obtain, without parental knowledge or consent, outpatient diagnosis or treatment of mental or emotional disorder or chemical dependency from professional counselors and marriage and family therapists licensed by Oregon Board of Licensed Professional Counselors and Therapists.

#### Public Hearing and Possible Work Session

SB 136 A

Provides that Oregon State Board of Nursing may authorize certified registered nurse anesthetists to prescribe prescription drugs under specified circumstances.

SB 725 A

Specifies terms for contracts entered into between Oregon Health Authority and coordinated care organizations.

SB 413 A

Requires insurer offering health benefit plans to provide annual notice to policyholders and certificate holders of specified information about Department of Consumer and Business Services' rate review process and consumer advocacy unit.

SB 470 A

Modifies, for purposes related to prescription monitoring program, definition of "practitioner."

Authorizes State Board of Pharmacy to designate prescription drugs for inclusion in prescription monitoring program.
