#### Work Session

SB 136 A

CARRIED OVER FROM THE 5/8/2013 AGENDA: Provides that Oregon State Board of Nursing may authorize certified registered nurse anesthetists to prescribe prescription drugs under specified circumstances.

SB 470 A

CARRIED OVER FROM THE 5/8/2013 AGENDA: Modifies, for purposes related to prescription monitoring program, definition of "practitioner."

Authorizes State Board of Pharmacy to designate prescription drugs for inclusion in prescription monitoring program.

#### Public Hearing and Possible Work Session

SB 169 A

Requires Oregon Health Authority, by February 1, 2015, to report to Legislative Assembly on prevalence of and costs related to prediabetes and diabetes in Oregon and on strategic plan to address prediabetes, diabetes and diabetes related complications.

SB 413 A

Requires insurer offering health benefit plans to provide annual notice to policyholders and certificate holders of specified information about Department of Consumer and Business Services' rate review process and consumer advocacy unit.

SB 460 A

Restricts substitution of biosimilar product for prescribed biological product.

SB 724 A

Requires Oregon Health Authority to establish method for accounting for coordinated care organization's costs in providing innovative, nontraditional health services.

SB 777 A

Modifies meeting requirements for Pharmacy and Therapeutics Committee of Oregon Health Authority.
