#### Work Session

SB 136 A

Provides that Oregon State Board of Nursing may authorize certified registered nurse anesthetists to prescribe prescription drugs under specified circumstances.

SB 470 A

Modifies, for purposes related to prescription monitoring program, definition of "practitioner."

Authorizes State Board of Pharmacy to designate prescription drugs for inclusion in prescription monitoring program.

#### Public Hearing and Possible Work Session

SB 281

Adds post-traumatic stress disorder to definition of "debilitating medical condition" for purposes of statutes authorizing medical use of marijuana.

SB 375 A

Establishes Stroke Care Committee in Oregon Health Authority.

SB 413 A

Requires insurer offering health benefit plans to provide annual notice to policyholders and certificate holders of specified information about Department of Consumer and Business Services' rate review process and consumer advocacy unit.

SB 569 A

Requires Oregon Health Authority to adopt uniform documentation requirements for credentialing providers of telemedicine services.

SB 722 A

Directs Oregon Health Authority to prepare human papillomavirus and comprehensive related cancer control plan addendum to Oregon Comprehensive Cancer Plan.

SB 777 A

Modifies meeting requirements for Pharmacy and Therapeutics Committee of Oregon Health Authority.
