#### Public Hearing and Possible Work Session

- SB 101 A  
Eliminates from impaired health professional program requirement that employers of program participants establish minimum training requirements for supervisors of participants.

#### Work Session

- SB 413 A  
Requires insurer offering health benefit plans to provide annual notice to policyholders and certificate holders of specified information about Department of Consumer and Business Services' rate review process and consumer advocacy unit.
- SB 444 A  
Creates offense of smoking in motor vehicle.
- SB 470 A  
Modifies, for purposes related to prescription monitoring program, definition of "practitioner."  
Authorizes State Board of Pharmacy to designate prescription drugs for inclusion in prescription monitoring program.
- SB 539  
Requires Department of Consumer and Business Services to apply to United States Secretary of Health and Human Services to participate in wellness program demonstration project.
- SB 572 A  
Requires hospital to implement safe patient handling policy.
- SB 621 A  
Requires Director of Oregon Health Authority to appoint members to advisory committees or subcommittees of Health Evidence Review Commission if commission determines it lacks required expertise or upon request by interested outside party.
- SB 721 A  
Imposes on nonschool athletic teams requirements for recognizing and responding to possible concussions.
- SB 724 A  
Requires Oregon Health Authority to establish method for accounting for coordinated care organization's costs in providing innovative, nontraditional health services .

- SB 725 A  
Specifies terms for contracts entered into between Oregon Health Authority and coordinated care organizations.
- SB 753  
Requires Oregon Health Authority to request specified information from potential contractors and, if certain conditions are met, to request proposals to establish and operate systems and technologies designed to detect and prevent improper payments in state medical assistance program.
- SB 777 A  
Modifies meeting requirements for Pharmacy and Therapeutics Committee of Oregon Health Authority.
