- HB 2149 \*\* \*\*Subsequent Referral(s) to Ways and Means  
CARRIED OVER FROM 4/15/13 AGENDA: Establishes institutional boards for University of Oregon and Portland State University.
- HB 2986  
CARRIED OVER FROM 4/15/13 AGENDA: Directs Department of Transportation to work with Department of Corrections, after consultation with Judicial Department, to assist individuals in obtaining driver license after release from Department of Corrections institution.
- HB 3079  
CARRIED OVER FROM 4/15/13 AGENDA: Requires for-profit institutions of higher education to provide students with certain fact sheets regarding costs of education, loans, job placement rates and related data prior to enrollment.
- HB 3120 \*\* \*\*Subsequent Referral(s) to Ways and Means  
CARRIED OVER FROM 4/15/13 AGENDA: Directs State Board of Education and State Board of Higher Education to work with Governor and conduct study on improving education governance.
- HB 3115 \*\* \*\*Subsequent Referral(s) to Ways and Means  
CARRIED OVER FROM 4/15/13 AGENDA: Prohibits public agencies from entering into public works contracts for which contract price exceeds \$750,000 unless public agency verifies that every employer under contract is approved apprenticeship training agent.
- HB 3341  
CARRIED OVER FROM 4/15/13 AGENDA: Exempts public universities and community colleges from requirement to enter into agreement with for-profit institutions of higher education before implementing potentially duplicative new post-secondary programs.
- HB 3245  
Requires inmates participating in apprenticeship program operated by Oregon Corrections Enterprises or Department of Corrections to be under direct supervision of department employee who is licensed or experienced in trade or occupation.
