HB 2349 \*\*  
Extends sunset for single-unit housing property tax exemption to 2025.

HB 2872 \*\*  
FIRST PUBLIC HEARING: Directs Oregon Department of Administrative Services to submit report related to outstanding bonds issued at request of Housing and Community Services Department, and programs and efforts supported by outstanding bonds, in event of reorganization or abolishment of Housing and Community Services Department.

HB 3220 \*\*  
FIRST PUBLIC HEARING: Directs Housing and Community Services Department to submit report regarding status of current projects and programs that promote housing stability for low-income individuals and families in state.

\*\*Subsequent Referral(s) to Ways and Means

HCR 26  
FIRST PUBLIC HEARING: Urges Oregonians to ensure that all families have means to raise their children in healthy environment.

SB 203  
FIRST PUBLIC HEARING: Specifies, for provisions related to Oregon's telephone assistance program, that "low income customer" is defined by Public Utility Commission by rule.

SB 22 A  
FIRST PUBLIC HEARING: Removes references to Eastern Oregon Training Center and references to operation of state training center by Department of Human Services.
