Work Session

- HB 2890
Repeals provision that prevents local governments from imposing conditions on approved permits that effectively establish sales price for residential development or limit purchase to class or group of purchasers.
- HB 2674 ** **Subsequent Referral(s) to Ways and Means
Requires public body to reserve one percent of appropriation for constructing, reconstructing or renovating park or public building for purpose of renovating or improving existing park or public building to meet current accessibility standards for persons with disabilities that are promulgated under Americans with Disabilities Act and regulations adopted pursuant to Act.
- HB 3445 ** **Subsequent Referral(s) to Ways and Means
Requires Department of Human Services to determine whether there are alternative placement options for child or ward in department's custody before committing child or ward to residential care or residential treatment.
- HB 3377 ** **Subsequent Referral(s) to Ways and Means
Limits amount Oregon State Lottery Commission may spend to advertise state lottery.
- HB 2984 ** **Subsequent Referral(s) to Ways and Means
Appropriates moneys to Department of Education for early childhood development center at Earl Boyles Elementar School.
- HB 2671 ** **Subsequent Referral(s) to Ways and Means
Creates State Office of the Public Guardian and Conservator to provide public guardian and conservator services for persons without relatives or friends willing or able to serve as guardians or conservators.
- HB 2781
Requires international matchmaking organization doing business in this state to provide criminal history record information and personal history information about client, and basic rights information, to noncitizen, nonresident recruit.
- HB 3007
Requires owner of residential facility to offer tenants opportunity to purchase facility before owner offers to sell facility to third party.
- HB 3112 ** **Subsequent Referral(s) to Revenue
Exempts from property taxation property of political subdivision used or intended to be used for affordable housing or leased or rented to persons of lower income for housing.

- HB 3131
Requires superintendent of Oregon State Hospital to establish and implement program for continuous employment of health care professionals who provide specified services.
- HB 3273 ** **Subsequent Referral(s) to Ways and Means
Establishes statewide audio newspaper service for persons who are blind or print-disabled.

Public Hearing and Possible Work Session

- HB 2013 ** **Subsequent Referral(s) to Ways and Means
Directs Early Learning Council and Department of Education to assist school districts in implementing process to assess children to determine their readiness for kindergarten.
- HB 3482
FIRST PUBLIC HEARING: Makes residential landlord responsible for maintenance of hazard trees on rented space for manufactured dwelling.
- HB 2721
FIRST PUBLIC HEARING: Requires public employees involved in administration of public assistance programs to report suspected fraud using procedures adopted by Department of Human Services or Oregon Health Authority.
