Public Hearing and Possible Work Session

- HB 2607
FRIST PUBLIC HEARING - Modifies method of determining amount of presentence incarceration credits for persons convicted of crime.
- HB 2710
FIRST PUBLIC HEARING - Provides that drone may be used by law enforcement agency for purpose of surveillance of person only pursuant to warrant or in emergency circumstances.
- HB 3371 **
FIRST PUBLIC HEARING - Provides for regulation of production, processing and sale of marijuana and marijuana-infused products. **Subsequent Referral(s) to Revenue

Work Session

- HB 2771
Requires Department of Public Safety Standards and Training to issue final order no later than 30 days after issuance of proposed order or form of order, and to adopt administrative law judge's findings of historical facts, when administrative law judge issues order approving application or certification of instructor or public safety officer.
- HB 2774 **
Repeals sunset on Task Force on Victims' Rights Enforcement. **Subsequent Referral(s) to Ways and Means
- HB 3249 **
Requires Department of Human Services to exercise due diligence to identify and locate grandparent of ward in department's custody and to give grandparent notice of hearings concerning ward. **Subsequent Referral(s) to Ways and Means
