Public Hearing and Possible Work Session

- HB 2833
FIRST PUBLIC HEARING - Adopts Uniform Unsworn Foreign Declarations Act.
- HB 2857 **
FIRST PUBLIC HEARING - Reduces amount payable by municipal or justice court for deposit in Criminal Fine Account from \$60 to \$45. **Subsequent Referral(s) to Ways and Means
- HB 2944
FIRST PUBLIC HEARING - Adopts Uniform Electronic Legal Material Act.
- HB 3087
FIRST PUBLIC HEARING - Limits amount of appeal fee that city or county may charge for quasi-judicial review of city or county decisions on land use application.
- SB 565 A
Modifies authority of Oregon Health and Science University to establish police force.

Work Session

- HB 2556
Provides that rate of interest on judgments that exceed \$1 million is lesser of five percent per annum or three percentage points more than discount rate in effect at Federal Reserve Bank in Federal Reserve district that includes Oregon.
- HB 2668
Expands definition of "place of public accommodation" to include places owned or maintained by public body and services provided by public body.
- HB 2834
Enacts Revised Uniform Law on Notarial Acts.
- HB 3047
Extends length of suspension of driving privileges if person fails to pay fine or obey order of court from 10 years to 20 years.
