CARRIED OVER FROM THE 4/8/2013 AGENDA - Authorizes civil forfeiture of motor vehicle if person is convicted of offense relating to driving while suspended or revoked.

HB 2024

FIRST PUBLIC HEARING - Expands crime of assault in third degree to include, under certain circumstances, causing physical injury to person employed at state mental hospital.

FIRST PUBLIC HEARING - Modifies standard for court commitment of person with mental illness.

FIRST PUBLIC HEARING - Requires Oregon Criminal Justice Commission to study and report on racial, ethnic and economic disparities in citizen interactions with police officers and on recruitment and retention of minorities b certain institutions related to law enforcement.

HB 2957

FIRST PUBLIC HEARING - Increases penalty for committing robbery with simulated deadly weapon.

HB 3434

FIRST PUBLIC HEARING - Defines "within 1,000 feet" as straight line measurement in radius extending 1,000 feet or less in every direction from a specified location or from boundary line of property for purposes of determining whether certain activities and operations are unlawful.

Creates crime of patronizing a trafficked child.

HB 2204

Directs Department of Corrections to establish risk assessment tool applicable to sex offenders.

HB 2595

Creates crime of interference with state forestland management in the second degree.

HB 2596

Provides private entity contracting with State Forestry Department for performance of forest practice on state forestland with cause of action against person intentionally committing act hindering, impairing, obstructing or attempting to hinder, impair or obstruct private entity performance of forest practice.

HB 3327

Authorizes court to set aside conviction for certain sex crimes under certain circumstances.

HB 3422

Creates crimes of drug-induced homicide and drug-induced assault.

HB 3467

Requires individual seeking disclosure of photographic records of arrested person from law enforcement agency to submit written request to agency, in person and with payment of fees.
