Work Session

HB 2746

Modifies provisions authorizing alteration, restoration or replacement of dwelling on tract of land zoned for exclusive farm use.

HB 3040

Prohibits specified nonfarm uses on land zoned for exclusive farm use.

Public Hearing and Work Session

HB 3124

FIRST PUBLIC HEARING: Requires local governments, including special districts, to enter into urban service agreements not later than January 1, 2015.

Work Session

HB 2028

Prohibits city or district from requiring consent by landowner to eventual annexation in exchange for providing extraterritorial service when city or district is providing service on behalf of another local government pursuant to intergovernmental agreement.

HB 2617

Requires that, in election proposing annexation, votes from city and territory to be annexed be counted separately to determine separate majorities if acreage to be annexed is 100 acres or more.

HB 2618

Allows city to withdraw part of district incorporated as or annexed to city from district only if city provides service formerly provided by district.

HB 2253

CARRIED OVER FROM 04/04/2013 AGENDA: Requires Portland State University Population Research Center to issue population forecasts for land use planning that are currently produced by counties.

HB 2254

CARRIED OVER FROM 04/04/2013 AGENDA: Creates option for cities with population of less than 10,000 to project need, based on population growth, for inclusion of land within urban growth boundary.

HB 2255

CARRIED OVER FROM 04/04/2013 AGENDA: Modifies planning period for inclusion of land within urban growth boundary from 20 years to 15 years.
