HB 3389

Requires beneficiary under residential trust deed to request resolution conference with grantor for purposes of negotiating foreclosure avoidance measure, unless beneficiary is eligible to claim exemption from requirement. *HB 3389 will be heard for purpose of considering amendment to replace measure.*

HB 3530 **

**Subsequent Referral(s) to Ways and Means

Makes revocation or modification of order issued for split use water lease mandatory if in-stream use of water under lease has resulted in injury to existing water right.

HB 2206

Allows Secretary of State to assume election-related duties, functions or powers of county clerk of county for which Governor has declared public safety services emergency due to fiscal distress.

HB 3404

Permits counties, under certain conditions, to receive assistance payments from County Assessment Function Fundi Assistance Account for 2013-2014 and 2014-2015 fiscal years that do not reflect changes in federal payments to county.

SB 496

Requires moneys in county's road fund and expended for patrolling to be used solely for direct and indirect costs associated with patrolling.

SB 581

Extends sunset date for provisions of law relating to county in fiscal distress and fiscal assistance board statutes.

SB 724 B

Requires Oregon Health Authority to establish method for accounting for coordinated care organization's costs in providing innovative, nontraditional health services.
