Work Session

- HB 2176 ** **Subsequent Referral(s) to Ways and Means
Authorizes State Treasurer to issue Article XI-N general obligation bonds to finance all or portion of state share of costs of seismic rehabilitation of emergency services buildings.
- HB 2179 ** **Subsequent Referral(s) to Ways and Means
Designates Emergency Communications Account as trust account exclusively for emergency communication purposes.
- HB 2475 ** **Subsequent Referral(s) to Tax Credits
Extends sunset for tax credit for provision of volunteer emergency medical services in rural area.
- HB 2883 ** **Subsequent Referral(s) to Revenue
Provides credit against income taxes for fees paid by member of Oregon National Guard or military reservist for Internet service provided outside United States.
- HB 3317 ** **Subsequent Referral(s) to Revenue
Extends period of applicability of emergency communications tax.

Public Hearing

- HB 2158 ** **Subsequent Referral(s) to Ways and Means
Allows nonresident veterans discharged under other than dishonorable conditions to pay tuition and fees at Oregon resident rates.
- HB 2162 ** **Subsequent Referral(s) to Ways and Means
Removes 12-month residency requirement for admission as residents to community colleges and public universities for persons who are members of specified uniformed services and their spouses and dependents.
