#### **Public Hearing**

SB 219

Provides that contracting agency may not spend more than five percent of estimated contract price for procurement services on conducting cost analysis as to whether contracting agency would incur less cost in conducting procurement than in performing services with contracting agency's own personnel or in making determination of whether performing services with contracting agency's own personnel is feasible.

#### **Public Hearing and Possible Work Session**

SR 845

Authorizes Governor and Director of the Department of Land Conservation and Development to exempt certain lanuse decisions from appeal by contract with member of traded sector industry that agrees to acquire and develop larg site industrial use employing at least 500 full-time employees.

SB 625

Limits timing and scope of State Fire Marshal plan review for construction, reconstruction, alteration or repair of building or structure.

SB 850

Creates offense of failure to keep vehicle out of far left lane.

SB 246 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Requires Oregon Business Development Department to establish and administer Oregon Industrial Site Readiness Program to make loans to qualified project sponsors for development of certified state and regionally significant industrial sites.

SB 253 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Requires Oregon Business Development Department to establish and administer Oregon Industrial Site Readiness Program providing grants to perform due diligence assessments of large industrial sites, to create detailed development plans to make large industrial sites market-ready and to conduct regional industrial site inventories.

SB 617

Requires Appraiser Certification and Licensure Board to convene panel to determine whether objective basis exists believe that alleged violation of provisions governing real estate appraisers has occurred before disciplining person.
