SB 850

CARRIED OVER FROM 4/15/2013 AGENDA: Creates offense of failure to keep vehicle out of far left lane.

SB 296

Authorizes holder of off-premises sales license, under certain conditions, to store wine at licensed premises for transport to other licensed premises for sale at retail.

SB 844

Directs Public Utility Commission to establish voluntary greenhouse gas emission reduction program for purposes concentivizing public utilities to invest in projects that reduce greenhouse gas emissions and providing benefits to customers of public utilities.

SB 849

Excludes from definition of "employment" service performed for corporation by individual with substantial ownership interest in corporation who is sole corporate officer and director of corporation.

SB 625

SB 782

CARRIED OVER FROM 4/15/2013 AGENDA: Requires state contracting agency that awards public improvement contract with contract price of more than \$5 million to set goal for apprentices to perform certain percentage, not to exceed 10 percent, of work hours on public improvement that workers in apprenticeable occupations perform.

SB 783

CARRIED OVER FROM 4/15/2013 AGENDA: Changes continuing education requirements for commercial construction contractors.
