CARRIED FROM 4/15/2013 AGENDA: Authorizes Governor and Director of the Department of Land Conservation and Development to exempt certain land use decisions from appeal by contract with member of trade sector industry that agrees to acquire and develop large-site industrial use employing at least 500 full-time employees.

SB 844

CARRIED OVER FROM 4/16/2013 AGENDA: Directs Public Utility Commission to establish voluntary greenhouse gas emission reduction program for purposes of incentivizing public utilities to invest in projects that reduce greenhouse gas emissions and providing benefits to customers of public utilities.

SB 678

Extends exclusive remedy protections of workers' compensation statutes to partners, limited liability company partners, general partners limited liability partners and limited partners.

CARRIED FROM 4/15/2013 AGENDA: Directs Department of Transportation to conduct interchange management study as part of redevelopment of Umatilla Chemical Depot.

SB 361

CARRIED OVER FROM 4/16/2013 AGENDA: Requires State Board of Higher Education, Oregon Health and Science University Board of Directors or community college board to receive approval from commodity commission for disposition of intellectual property if commission provided monetary assistance to board to acquire property.

- SB 561
CARRIED OVER FROM 4/16/2013 AGENDA: Modifies provision authorizing tariff schedules for use by public utilities that provide energy resource measures to individual property owners or customers.
- SB 562
CARRIED OVER FROM 4/16/2013 AGENDA: Directs electric utility to provide credit to subscribing customer that receives electric service within service territory of electric utility for electricity generated by community net metering facility under certain circumstances.
- SB 625
CARRIED FROM 4/16/2013 AGENDA: Limits timing and scope of State Fire Marshal plan review for construction, reconstruction, alteration or repair of building or structure.
- SB 782
CARRIED FROM 4/16/2013 AGENDA: Requires state contracting agency that awards public improvement contract with contract price of more than \$5 million to set goal for apprentices to perform certain percentage, not to exceed 1 percent, of work hours on public improvement that workers in apprenticeable occupations perform.
- SB 783
CARRIED OVER FROM 4/16/2013 AGENDA: Changes continuing education requirements for commercial construction contractors.
- SB 557 ** **Subsequent Referral(s) to Ways and Means
Abolishes State Landscape Contractors Board.
