SB 74

CARRIED OVER FROM THE 4/12/2013 AGENDA: Changes calculation of present value of adjusted premiums for certain types of life insurance so that present value of all adjusted premiums equals 50 percent of adjusted premium for first policy year instead of 40 percent of adjusted premium for first policy year.

SB 489

CARRIED OVER FROM THE 4/12/2013 AGENDA: Repeals requirement that certain local governments make health care insurance coverage available to certain retirees.

SB 525

CARRIED OVER FROM THE 4/12/2013 AGENDA: Establishes requirements under which debt buyer may bring legal action to collect debt.

SB 573

CARRIED OVER FROM THE 4/12/2013 AGENDA: Establishes right of employee for civil action based on unpaid wages.

SB 574

CARRIED OVER FROM THE 4/12/2013 AGENDA: Permits consumer to request that consumer reporting agency place, temporarily lift or remove security freeze on protected consumer's consumer report if consumer provides sufficient proof of consumer's authority to act on protected consumer's behalf.

SB 615

CARRIED OVER FROM THE 4/12/2013 AGENDA: Prohibits Department of Transportation from imposing civil penalty on vehicle dealer if vehicle dealer fails to submit notice of sale to department.

SB 683

CARRIED OVER FROM THE 4/12/2013 AGENDA: Prohibits health care practitioners from referring patients to health care entities in which practitioner has beneficial interest or with which practitioner has compensation arrangement, subject to specified exceptions.

SB 684

CARRIED OVER FROM THE 4/12/2013 AGENDA: Specifies requirements for persons to intervene in contested case proceedings conducted by Department of Consumer and Business Services on rate filings.

#### SB 768
