HB 2654 A

CARRIED OVER FROM THE 5/3/2013 AGENDA: Prohibits employer from requiring or requesting employee or applicant for employment to provide access to personal social media account or to add employer to social media contact list.

HB 2683 A

CARRIED OVER FROM THE 5/3/2013 AGENDA: Authorizes employer to pay wages due employee through direct deposit into employee's account .

HB 2239

Requires certain entities previously exempt from requirement to have license in order to engage in business of maki mortgage loans to now obtain license from Department of Consumer and Business Services.

HB 2528

Removes cap on amount in real estate loan agreement that is subject to requirement to pay interest to borrower on funds that lender collects for lender's security protection provision.

HB 2531

Expands definition of "appraisal management company" to include companies ordering appraisals for purposes not related to mortgage loans or mortgage securities.

HB 2845

Prohibits owner of self-service storage facility from selling or offering to sell insurance unless owner applies for and receives limited license from Director of Department of Consumer and Business Services.

HB 2914

Increases amount of money and goods that person may find without giving notice to county clerk.

HB 2241

Permits Director of Department of Consumer and Business Services to share information related to acquisitions of insurers under certain circumstances.
