HB 2241

CARRIED OVER FROM THE 5/29/2013 AGENDA: Permits Director of Department of Consumer and Business Services to share information related to acquisitions of insurers under certain circumstances.

HB 2383 A

CARRIED OVER FROM THE 5/29/2013 AGENDA: Prohibits merchant from requiring statement of account as condition for cardholder to obtain refund of amount in payment card transaction.

HR 2418 A

CARRIED OVER FROM THE 5/29/2013 AGENDA: Modifies definition of "supervisory employee" for purposes of public employee collective bargaining law.

HB 2448 A

CARRIED OVER FROM THE 5/29/2013 AGENDA: Requires issue subject to collective bargaining during term of collective bargaining agreement that is not resolved through negotiation or mediation to be resolved through binding arbitration.

HB 2821 A

CARRIED OVER FROM THE 5/29/2013 AGENDA: Requires insurer to pay claims up to maximum coverage under policy of uninsured motorist coverage based on insured's total damages for personal injuries, less amounts recovered from other motor vehicle liability insurance policies.

HB 2822 A

CARRIED OVER FROM THE 5/29/2013 AGENDA: Requires publication of information about execution sale of real property by Internet posting and in newspaper of general circulation.

HB 2929 A

CARRIED OVER FROM THE 5/29/2013 AGENDA: Permits trustee to rescind trustee's sale within 10 calendar days if trustee asserts that error occurred during trustee's sale, if grantor and beneficiary agreed to foreclosure avoidance measure that would postpone or discontinue trustee's sale or if beneficiary accepted funds to reinstate trusteed and obligation.

HB 3070 A

CARRIED OVER FROM THE 5/29/2013 AGENDA: Requires disclosure of shipping and handling charges in sale or advertisement of consumer good.

HB 3159 A

CARRIED OVER FROM THE 5/29/2013 AGENDA: Directs each county and each city with population of 15,000 or more to set maximum rates for towing and related services when tower tows motor vehicle without consent or authorization of owner or operator.

HB 3160 A

CARRIED OVER FROM THE 5/29/2013 AGENDA: Includes insurance in definition of real estate, goods and services that are subject to penalties for unlawful trade practices.

HB 3342

CARRIED OVER FROM THE 5/29/2013 AGENDA: Prohibits public employer from assisting, promoting or deterring union organizing and from using public property to hold meeting with employee or supervisor if purpose of meeting is to assist, promote or deter union organizing.
