- SB 132  
Changes certain documentation that must be submitted to school administrator for purpose of opting out of immunizations.
- SB 169  
Requires Oregon Health Authority, Oregon Health Insurance Exchange Corporation, Oregon Educators Benefit Board and Public Employees' Benefit Board to identify activities that address diabetes, diabetes care and complications from diabetes.
- SB 325 \*\* \*\*Subsequent Referral(s) to Tax Credits  
Extends sunset for tax credit for practice of rural medicine.
- SB 626  
Renames Long Term Care Ombudsman as Ombudsman for Vulnerable Adults and renames office of Long Term Care Ombudsman as office of Ombudsman for Vulnerable Adults.
- SB 777  
Modifies meeting requirements for Pharmacy and Therapeutics Committee of Oregon Health Authority.
- SB 724  
Requires Oregon Health Authority to establish payment methodology to reimburse coordinated care organization's costs in providing innovative, nontraditional health services for which there are no established billing codes.
- SB 365  
Establishes requirements for coverage of autism spectrum disorders by health benefit plans, Public Employees' Benefit Board and Oregon Educators Benefit Board.
- SB 725  
Specifies terms for contracts entered into between Oregon Health Authority and coordinated care organizations.
