Work Session

- SB 365
CARRIED OVER FROM 4/15 AGENDA - Establishes requirements for coverage of autism spectrum disorders by health benefit plans, Public Employees' Benefit Board and Oregon Educators Benefit Board.
- SB 382
CARRIED OVER FROM 4/11/13 AGENDA - Directs Department of Consumer and Business Services and Oregon Health Authority to jointly develop form that providers in this state may use to request prior authorization for prescription drug benefits.
- SB 823 **
CARRIED OVER FROM 4/11/13 AGENDA - Requires Oregon Health Authority to create new programs and expand existing programs to increase capacity statewide to provide mental health services and serve individuals with mental illness. **Subsequent Referral(s) to Ways and Means
- SB 136
CARRIED OVER FROM 4/11/13 AGENDA - Provides that Oregon State Board of Nursing may authorize certified registered nurse anesthetists to write prescriptions and dispense prescription drugs.
- SB 457
CARRIED OVER FROM 4/11/13 AGENDA - Requires Oregon Health Authority to report to Seventy-eighth Legislative Assembly on changes necessary to implement federal health care law.
- SB 460
CARRIED OVER FROM 4/11/13 AGENDA - Restricts substitution of biosimilar product for prescribed biological product.
- SB 572
Requires hospital to implement safe patient handling policy.
- SB 559
Requires Department of Human Services to provide adults with developmental disabilities needing comprehensive services at least three options for residential care.
- SB 564
Gives adult with developmental disability receiving support services for adults option to remain in home placement long as home placement is less costly than residential care facility.

AGENDA (Cont.)
April 16, 2013

- SB 640
Requires Department of Human Services to calculate amount paid to all providers of services to adults with developmental disabilities using uniform tool that reimburses for all services provided under individualized written service plan.
- SB 641
Requires Department of Human Services to calculate amount paid to all providers of services to adults with developmental disabilities using uniform tool that reimburses for all services provided under individualized written service plan.
- SB 436
Requires coordinated care organizations, by December 1, 2017, to maximize use of school-based health centers and coordinate care with certain programs and entities.
- SB 802
Provides that institution or program accredited by Commission on Dental Accreditation of American Dental Association does not need to name actively licensed dentist as dental director of dental offices or clinics owned or operated by institution or program.

Public Hearing and Possible Work Session

- SB 373
Requires coordinated care organization to provide oral health care through contracts with dental care organizations unless no dental care organization provides care in geographic area served by coordinated care organization.
