#### Possible Introduction of Committee Measures

#### Public Hearing and Possible Work Session

- SB 68  
Eliminates mandatory minimum sentence for persons under 18 years of age convicted of committing crime of using child in a display of sexually explicit conduct.
- SB 481  
Establishes Oregon Center for Policing Excellence within Department of Public Safety Standards and Training for purposes of making policing in Oregon more effective and efficient, making communities safer and reducing number of offenders entering criminal justice system.
- SB 779  
Requires Attorney General to appoint attorney to lead investigation when peace officer uses deadly physical force.
- SB 780  
Requires grand jury proceeding involving use of deadly force by police officer to be recorded, transcribed and made available to public.
- SB 781  
Changes standard for use of deadly force from officer's reasonable belief that certain circumstances exist in which other person is undertaking particular conduct to belief by reasonable person in officer's circumstances that other person is undertaking particular conduct.
