SB 794

Requires Advisory Committee on Medical Marijuana to meet five times per year.

SB 30

CARRIED OVER FROM THE 4/17/2013 AGENDA - Adds crimes to list of sex crimes requiring person convicted of sex crime or adjudicated for act that constitutes sex crime to register as sex offender after being discharged, paroled or released from correctional or detention facility.

SB 70

CARRIED OVER FROM THE 4/17/2013 AGENDA - Eliminates July 1, 2013, sunset of provision that limits length of incarceration court may impose when certain probationary sentences are revoked for reasons other than commission of new crime.

SB 90

Modifies certification system for shorthand reporters.

SB 347

CARRIED OVER FROM THE 4//17/2013 AGENDA - Modifies crime applicable to possession of firearm, or instrument used as dangerous weapon, while in or on school grounds.

SB 421

CARRIED OVER FROM THE 4/17/2013 AGENDA - Authorizes district attorney to initiate commitment proceeding when person charged with certain crimes lacks capacity to stand trial and is dangerous and in need of commitment.

SB 426

CARRIED OVER FROM THE 4/17/2013 AGENDA - Increases from 180 days to two years maximum period of indefinite commitment of persons who lack capacity to stand trial due to mental illness and have been charged with certain crimes.

## AGENDA (Cont.) April 18, 2013

- SB 492
  - Requires district attorney to disclose to defendant data, documents, tangible objects or information that reasonably appears to be favorable to defendant with respect to determination of guilt, preliminary matter or sentence to be imposed.
- SB 610
  - Modifies types of conditions qualifying as disability and types of animals qualifying as assistance animals for purposes of accessing places of public accommodation and places of access to state government services, programs activities and for purposes of cause of action for harm to assistance animal.
- SB 673
  - CARRIED OVER FROM THE 4/17/2013 AGENDA Creates crime of patronizing a trafficked child.
- SB 694
  - CARRIED OVER FROM THE 4/17/2013 AGENDA Requires law enforcement agency to alter police vehicle so that it no longer resembles police vehicle before selling or transferring title.
- SB 696
  - CARRIED OVER FROM THE 4/17/2013 AGENDA Modifies exemption from execution applicable to certain firearms.
- SB 699
  - CARRIED OVER FROM THE 4/17/2013 AGENDA Modifies laws prohibiting possession of firearms in public buildings.
- SB 700
  - CARRIED OVER FROM THE 4/17/2013 AGENDA Requires person to request criminal background check before transferring firearm to any other person outside the transferor's immediate family.
- SB 796
  - CARRIED OVER FROM THE 4/17/2013 AGENDA Requires person applying for concealed handgun license to pass firing range test.
- SB 713
  - CARRIED OVER FROM THE 4/17/2013 AGENDA Permits firearms training facilities in exclusive farm use zones.
- SB 851
  - Directs Public Utility Commission to appoint executive director of Oregon Board of Maritime Pilots.
