#### Public Hearing and Possible Work Session

- HB 2384 A  
Authorizes civil and criminal forfeiture of motor vehicle if person is convicted of certain offenses relating to driving while suspended or revoked.
- HB 3327 A  
Authorizes court to set aside conviction for certain sex crimes under certain circumstances.
- HB 3434  
Defines "within 1,000 feet" as straight line measurement in radius extending 1,000 feet or less in every direction from a specified location or from boundary line of property for purposes of determining whether certain activities and operations are unlawful.

#### Work Session

- HB 2962 A  
Repeals statute requiring trial within reasonable period of time for criminal defendants.
- HB 2601 A  
Modifies restriction on use of photographs taken using photo red light camera.
- HB 3253 A  
Requires sex offender who is released into Oregon, who is placed on probation in Oregon or who moves into Oregon, to register as sex offender if jurisdiction of conviction requires registration, regardless of whether conviction would be sex crime in this state.
