CARRIED OVER FROM THE 5/29/2013 AGENDA - Requires sex offender who is released into Oregon, who is placed on probation in Oregon or who moves into Oregon, to register as sex offender if jurisdiction of conviction requires registration, regardless of whether conviction would be sex crime in this state.
