#### Possible Introduction of Committee Measures

##### Public Hearing

SB 841  
Allows winery to be sited on land zoned for mixed farm and forest use.

##### Public Hearing and Possible Work Session

SB 357  
Establishes policy direction for management of state forestlands, including management for timber harvesting.

SB 538  
Allows two or more counties to petition Land Conservation and Development Commission to establish by rule regional definitions for "agricultural land" and "forestland" for purposes of land use planning in proposed region.

SB 743  
Allows owner of territory not contiguous to city to annex to city if land is within 200 feet of existing city boundary, city was under jurisdiction of boundary commission on January 1, 2007, and owner acquired interest in territory prior to January 1, 1973.

##### Work Session

SB 77  
Requires appellate review of quasi-judicial land use decisions and limited land use decisions directly related to and made in response to land use application to be conducted in single proceeding in which Land Use Board of Appeals has joined all appeals.

SB 245 \*\*  
Authorizes designation of enterprise zone and zone and city for electronic commerce, addition of zone cosponsor and change of enterprise zone boundary without application process, subject to determination by Oregon Business Development Department that certain statutory requirements met. \*\*Subsequent Referral(s) to Finance and Revenue

SB 257 \*\*  
Creates fund to allow State Board of Forestry to issue loans to United States Forest Service to prepare for and conduct sale of forest products to be harvested from federal forestlands within state. \*\*Subsequent Referral(s) to Ways and Means

SB 633

Makes legislative finding and declaration that regulation of agricultural seed, flower seed and vegetable seed and products of agricultural seed, flower seed and vegetable seed be reserved to state.
