Public Hearing and Possible Work Session

HB 2158 A

Directs public universities and community colleges to charge nonresident veteran who is undergraduate student tuition and fees no greater than resident rate if nonresident veteran was discharged under other than dishonorable condition and attended elementary or secondary school in any state or territory, District of Columbia or Commonwealth of Puerto Rico within five years immediately prior to receiving high school diploma or leaving school before receiving high school diploma, attended elementary or secondary school in this state within three years immediately prior to receiving high school diploma or leaving school before receiving diploma and received high school diploma from secondary school in this state or received equivalent of high school diploma.

Where nonresident veteran who is undergraduate or graduate student does not meet specified requirements, directs public universities and community colleges to charge non-resident veteran tuition and fees no greater than resident rate plus 50 percent of difference between resident rate and nonresident rate.

HB 2789

Directs schools to provide drills and instruction on safety threats.

Work Session

HB 2037 A

Requires, under specified circumstances, certain professional regulatory boards to issue authorization to practice profession to spouse or domestic partner of active member of Armed Forces who is subject of military transfer to Oregon.

HB 2083 A

Permits service member called into active service to suspend and reinstate provision of telecommunications, Internet television, health spa and health club services.

HB 3494

Directs Department of Transportation to erect and maintain roadside memorial sign for Tyrone Woods.
