### STATUTORY QUALIFICATIONS: ORS 679.230

Affirmative action policy: See ORS 182.100. Diversity criteria: See ORS 236.115.

- Oregon residency and U.S. citizenship
- Ten members, appointed by the Governor to four-year terms:
  - Six active, licensed dentists of which one shall be a dentist practicing in a specialty recognized by the American Dental Association (BECK, HONGO, MAGNUSON, PARKER, SCHWINDT, SMITH)
  - Two public members (HARVEY, MORRIS)
  - Two active licensed dental hygienists (DAVIDSON, MASON)
- Appointments of dentists may be selected by the Governor from a list of five names for each appointment suggested by the Oregon Dental Association. Appointments of dental hygienists may be selected by the Governor from a list of five names suggested by the Oregon Dental Hygienists' Association. Appointments of dental specialists may be selected by the Governor from among one name suggested by each of the organizations representing a dental speciality.
- A board member shall be removed immediately from the board if, during the member's term, the member:
  - Is not a resident of this state;
  - Has been absent from three consecutive board meetings, unless at least one absence is excused;
  - Is not a licensed dentist or a retired dentist whose license was in good standing at the time of retirement, if the board member was appointed to serve on the board as a dentist or a dental specialist; or
  - Is not a licensed dental hygienist or a retired dental hygienist whose license was in good standing at the time of retirement, if the board member was appointed to serve on the board as a dental hygienist.

## DUTIES AND AUTHORITY: ORS 679.250

- Employ inspectors, examiners and other staff to investigate and prosecute alleged violations and to enforce provision of ORS chapter 679
- Conduct examinations for applicants to be licensed as dentists and dental hygienists

- Adopt and enforce rules for regulating the practice of dentistry, services of dental hygienists and other dental personnel, and administration of general anesthesia and conscious sedation
- Initiate and conduct investigations and hearings on disciplinary actions, issue subpoenas
- Discipline licensees.
