- Not a public office holder or candidate
- Hold no other position for profit with limited exceptions
- Removable for cause after hearing

**DUTIES AND AUTHORITY:**                      **ORS 240.086, 240.100, 240.115, and 240.123**

- Maintain actions to enforce State Personnel Relations Law
- Maintain action or proceeding to secure compliance with law
- Review personnel action for employee not in collective bargaining unit
- Review and enforce arbitration awards
- Administer oaths, subpoena witnesses, compel production of investigatory papers
- Rulemaking
- Employ personnel
