- Eleven members
 - Nine members appointed by the Governor to three-year terms (**COLLIN**, COLLYMORE, DIXON, **JAMES**, MANNING, MORRIS, STONE, **TRICE**, WALKER, WILSON)
 - Two legislators, one appointed by the Senate President (SEN. MONROE) one appointed by Speaker of the House of Representatives (REP. FREDERICK) each of whom has a two-year term.
- Appointments shall be made to ensure representation of the Black population in Oregon

DUTIES AND AUTHORITY: ORS 185.420, 185.430, 185.440

- Elect a chair and vice-chair
- Monitor programs and legislation concerning needs of the Black population
- Identify and research problem areas and issues affecting the Black community and recommend actions to the Governor and Legislature
- Be a community-government liaison for the Black community
- Encourage Black representation on state boards and commissions
- Employ an executive director and other staff necessary to carry out its function; may establish special committees
