- Ten members appointed by the Governor for two year terms.
  - Five members from organized labor shall represent subject workers (GOLDBERG, GUINEY, MOHLIS, QUINN, STANGE).
  - Five members shall represent subject employers (ANDERSON, COCKERAM, DUNCAN, NISHIMOTO, SUE).
  - The director shall serve ex officio (ALLEN).

**DUTIES AND AUTHORITY:**   **ORS 656.790**

- Biennially review the standards for evaluation of permanent disability adopted under ORS 656.726. Recommend to the director factors to be included or such other modification of application of the standards as the committee deems appropriate
- Advise the director regarding any proposed changes in the operation of programs funded by the Workers' Benefit Fund. The committee shall report its findings to the director for such action as the director deems appropriate.
- The committee may report to the Legislative Assembly such findings and recommendations it considers appropriate, on the following: Decisions of the Supreme Court and Court of Appeals that have significant impact on the workers' compensation system; adequacy of workers' compensation benefits; medical and legal system costs; adequacy of assessments for reserve programs and administrative costs; the operation of programs funded by the Workers' Benefit Fund.
- May hire, subject to director's approval, experts it may require to discharge its duties.
