### **DUTIES AND AUTHORITY:** ORS 413.301 – ORS 413. 303; ORS 413.306; and ORS 413.308

- The council may adopt rules necessary to administer the laws it is charged with administering.
- The council is responsible for setting specific health information technology goals and developing a strategic health information technology plan for the state.
- Monitors progress and provides oversight in achieving health information technology goals.
- Maximizing the distribution of resources spent on health information technology in the state
- Create and provide oversight for public-private purchasing collaborative or alternative. mechanisms to obtain hardware, software and technical support to maintain health information technology.
- The council will identify and select industry standards for all health information technology for purchase by the collaborative including standards for:
  - Venders, hardware, software, and support services
  - Ensuring privacy and security controls
- Shall coordinate health care sector activities to move the adoption of health information technology forward through coordination and leveraging of community resources and education of public and health care providers on the benefits of risks of information technology infrastructure investment.
- The council oversees the implementation of a personal health records bank and building of a statewide health information exchange by the Oregon Health Authority.
- Determines appropriate method to reimburse providers for use of electronic health records.
