



Department of Human Services Expenditure History/2013-15 Governor's Budget









Department of Human Services Agency Programs



- Self Sufficiency Assistance to low-income families to promote family stability, includes food and cash assistance, access to child care and medical assistance eligibility work
- Child Welfare Protection, prevention and regulatory activities to keep children safe, includes substitute care, adoption assistance and in-home supports
- Vocational Rehabilitative Services Assists youth and adults with disabilities to obtain, maintain, or advance employment
- Developmental Disabilities Helps people with intellectual and developmental disabilities have the best quality of life at all stages in their lifespan
- Aging and People with Disabilities Assists seniors and people with disabilities of all ages to achieve well-being, includes long-term care services and financial support

Department of Human Services

• Cost drivers:

- Demographic and economic environment
- o Caseload increases
- Cost of services, medical inflation
- Federal funding and policy changes
- Provider and community partner infrastructure and capacity



Department of Human Services

• Revenues:

- o General Fund
- Federal Funds Supplemental Nutrition Assistance Program, Medicaid matching funds, Temporary Assistance for Needy Families Block Grant.
- Other Funds –Provider tax, Child Care Development Fund (transferred from Early Learning Division as Other Funds), other collections and charges for services.



- Aging and People with Disabilities
 - Assumes additional Medicaid funding through State Plan K Amendment
 - Continues Nursing Facility Provider Tax and corresponding increases to Nursing Facility rates
 - Additional investments:
 - Improve services for older clients with mental illness, traumatic brain injury, and other dementia related diseases
 - **×** Counseling services to help people make informed choices
 - × Pilot innovative approaches to improvements
 - × Increases in Certified Nursing Assistants (CNA) staffing ratios
 - Rate increases to in-home and community-based providers
 - Increase access and eligibility, case management and adult protective services



Developmental Disability

- Assumes additional Medicaid funding through State Plan K Amendment
 - **×** Expand family to family networks
 - Increase integrated employment options for transition age youth and working-age adults
 - **x** Restore Fairview Trust to pre-2011-13 levels
 - × Implement statewide electronic record keeping system
 - Increase available funding for personal care workers and adult foster care providers



• Self Sufficiency

- Backfills one-time funding used in 2011-13
- Continues modernization of DHS technology systems
- Increases Employment Related Daycare biennial average caseload to just over 9000
- Implements a three year time limit for the Temporary Assistance for Needy Families cash assistance program

- Investment to implement Differential Response Model
- Statewide implementation of the Strengthening, Preserving and Reunification of Families – SB 964 (2011)
- Investment in services available to homeless and runaway youth
