22 **"ESTABLISHMENT AND INDEPENDENCE OF GOVERNING BOARDS**

"<u>SECTION 1.</u> (1) The Legislative Assembly finds that the State of
 Oregon will benefit from having public universities with governing
 boards that:

4 "(a) Provide transparency, public accountability and support for the
5 university.

6 "(b) Are close to and closely focused on the individual university.

7 "(c) Do not negatively impact public universities that do not have
8 governing boards.

9 "(d) Lead to greater access and affordability for Oregon residents
10 and do not disadvantage Oregon students relative to out-of-state stu11 dents.

"(e) Act in the best interests of both the university and the State
of Oregon as a whole.

"(f) Promote the academic success of students in support of the
 mission of all education beyond high school as described in ORS
 351.009.

17 "(2) The Legislative Assembly also finds that:

"(a) Even with universities with governing boards, there are
 economy-of-scale benefits to having a coordinated university system.

20 "(b) Even with universities with governing boards, shared services
21 may continue to be shared among universities.

"(c) Legal title to all real property, whether acquired before or after
the creation of a governing board, through state funding, revenue
bonds or philanthropy, shall be taken and held in the name of the
State of Oregon.

"(d) The Legislative Assembly has a responsibility to monitor the
 success of governing boards at fulfilling their missions, their compacts
 and the principles stated in this section.

²⁹ "<u>SECTION 2.</u> As used in sections 1 to 23 of this 2013 Act:

30 "(1) 'Governing board' means a governing board established by a

university under section 3 of this 2013 Act that manages the affairs
of the university by exercising and carrying out all of the powers,
rights and duties that are expressly conferred upon the board by law,
or that are implied by law or are incident to such powers, rights and
duties.

"(2) 'University with a governing board' means a public university
listed in section 3 of this 2013 Act that has established a governing
board.

9 "SECTION 2a. (1) A university with a governing board is a govern-10 mental entity performing governmental functions and exercising gov-11 ernmental powers. The university is not considered a unit of local or 12 municipal government or a state agency, board, commission or insti-13 tution for purposes of state statutes or constitutional provisions.

"(2) A claim against a university with a governing board is not a claim against the State of Oregon. All liabilities of a university with a governing board are the sole responsibility of the university with a governing board. This subsection applies to all liabilities existing on or arising after the operative date of this section.

"SECTION 3. (1) A governing board is established for each of the
 following public universities:

21 "(a) University of Oregon;

22 "(b) Portland State University; and

"(c) Oregon State University, if the president of Oregon State Uni versity notifies the Governor that the university will become a uni versity with a governing board in the manner set forth in section 168
 of this 2013 Act.

27 "(2)(a) The University of Oregon governing board shall be known
28 as the Board of Trustees of the University of Oregon.

"(b) The Portland State University governing board shall be known
 as the Board of Trustees of Portland State University.

"(c) The Oregon State University governing board shall be known
as the Board of Trustees of Oregon State University, if the president
of Oregon State University notifies the Governor that the university
will become a university with a governing board in the manner set
forth in section 168 of this 2013 Act.

6 "SECTION 4. Upon a request to the Governor by the president of 7 Eastern Oregon University, Oregon Institute of Technology, Southern 8 Oregon University or Western Oregon University to establish a gov-9 erning board for the university, or upon a request made by the presi-10 dent of Oregon State University after January 1, 2014, to establish such 11 a board, the Higher Education Coordinating Commission shall:

12 "(1) Evaluate and determine whether:

"(a) There is clear evidence of support for a governing board by the
 university community;

15 "(b) The university has the capacity and capability to be governed
16 by a governing board; and

"(c) A governing board of the university will function in accordance
with the findings set forth in section 1 of this 2013 Act.

"(2) Make recommendations to the Legislative Assembly as to
whether, in addition to the public universities with governing boards
listed in section 3 of this 2013 Act, a governing board should be established for the university.

23 "SECTION 5. (1) On an annual basis, the Higher Education Coordi-24 nating Commission shall submit to the Legislative Assembly an eval-25 uation of each university with a governing board. The commission 26 may make recommendations to the Legislative Assembly regarding the 27 ability of the university to meet academic goals and fulfill its fiduciary 28 responsibilities.

29 **"(2) The evaluation must include:**

30 "(a) A report on the university's achievement of outcomes, meas-

ures of progress, goals and targets as described in the university's
 achievement compact with the Oregon Education Investment Board;

"(b) An assessment of the university's progress toward achieving
the mission of all education beyond high school as described in ORS
351.009; and

"(c) An assessment as to how well the establishment of a governing
board at the university comports with the findings set forth in section
1 of this 2013 Act.

9 "<u>SECTION 6.</u> (1) A governing board for a public university must be 10 formed and maintained as provided in this section.

"(2)(a) The Governor shall appoint 11 to 15 members of the govern ing board, subject to confirmation by the Senate in the manner pro vided in ORS 171.562 and 171.565.

"(b) For each appointment, the university shall nominate a slate
 of candidates and shall forward the recommended candidates to the
 Governor for consideration.

"(c) The governing board must include one person who is a student
 enrolled at the university.

"(d) The president of the university shall be an ex officio nonvoting
 member of the governing board.

"(3)(a) The term of office for each appointed nonstudent member
 of the governing board is four years.

"(b) The term of office of each student member of the governing
board is two years.

"(c) A member appointed to the governing board may not be appointed to serve consecutively more than two full terms as a board
 member.

"(d) The Governor may remove any appointed member of the gov erning board at any time for cause, after notice and public hearing,
 but may not remove more than three members within a period of four

1 years, unless it is for corrupt conduct in office.

"(e) Vacancies shall be filled by appointment by the Governor for
the remainder of the unexpired term.

4 "(4) Except for the president of the university and the student
5 member of the governing board, a member of the board may not be
6 an employee of the university.

"(5) The governing board shall select one of its members as chairperson and another as vice chairperson for such terms and with duties and powers as the board considers necessary for the performance of the functions of those offices. The governing board shall adopt bylaws concerning how a quorum is constituted and when a quorum is necessary.

"(6) The governing board shall meet at least once quarterly, and
 may meet at the call of the chairperson or a majority of the voting
 members of the board.

"(7) A newly formed governing board shall convene for the first
 time between the beginning of January and the end of July of an
 even-numbered year.

19 "SECTION 7. Notwithstanding the term of office specified in section 20 6 of this 2013 Act, the initial term of a member appointed to a gov-21 erning board by the Governor may be adjusted so that one-half, as 22 nearly as possible, of the members of the board are appointed 23 biennially.

"<u>SECTION 8.</u> (1) A university with a governing board shall enter
 into an achievement compact with the Oregon Education Investment
 Board for each fiscal year.

"(2) The governing board shall adopt a mission statement for the
 university, which shall be forwarded to the Higher Education Coordi nating Commission for approval.

30 "(3) A university with a governing board shall submit any signif-

icant change in the university's academic programs to the Higher
Education Coordinating Commission for approval. The commission
shall establish, by rule, what constitutes a significant change to a
university's academic program. The commission shall further ensure
that approved programs:

6 "(a) Are consistent with the mission statement of the university;

7 "(b) Do not unnecessarily duplicate academic programs offered by
8 Oregon's other public universities;

9 "(c) Are not located in a geographic area that will cause undue
10 hardship to Oregon's other public universities; and

"(d) Are allocated among Oregon's public universities to maximize
 the achievement of statewide needs and requirements.

"(4)(a) On or before May 1 of each even-numbered year, a university
 with a governing board shall submit to the Higher Education Coordi nating Commission a funding request applicable to the biennium be ginning on July 1 of the following year.

"(b) Pursuant to ORS 351.052, the Higher Education Coordinating
 Commission shall submit a funding request to the Governor on behalf
 of all public universities listed in ORS 352.002, including universities
 with governing boards.

"(c) The Governor's biennial budget submitted to the Legislative Assembly may include funding requests from public universities, including universities with governing boards. Funding approved by the Legislative Assembly must specify that the moneys be appropriated to the Higher Education Coordinating Commission for distribution to public universities listed in ORS 352.002.

"(5) As part of a funding request submitted under subsection (4) of this section, a university with a governing board may request, and appropriations may include, funding for education and general operations, statewide public services, state-funded debt service, capital improvements, deferred maintenance, special initiatives and investments.

"<u>SECTION 9.</u> (1)(a) In consultation with the Governor, or the
 Governor's designee, the governing board shall appoint and employ a
 president of the university.

6 "(b) The governing board shall prescribe the president's compen-7 sation and terms and conditions of employment.

8 "(2) The president of the university is the president of the faculty. 9 The president is also the executive and governing officer of the uni-10 versity, except as otherwise provided by statute or action of the gov-11 erning board. Subject to the supervision of the governing board, the 12 president of the university has authority to direct the affairs of the 13 university.

"(3) Except in the case of an interim or acting president, the hiring committee for the president of a university with a governing board shall include representatives of the university community and at least one other president of a public university based in Oregon.

"(4) The governing board is responsible for the reappointment or
 removal of the president of the university.

20 "(5) A university with a governing board may appoint and employ 21 any instructional, administrative, professional, trade, occupational 22 and other personnel as are necessary or appropriate and establish their 23 compensation and terms and conditions of employment, subject to the 24 limitations set forth in section 14 (1) and (2) of this 2013 Act.

"<u>SECTION 10.</u> (1) Except as set forth in this section, the governing
 board may authorize, establish, eliminate, collect, manage, use in any
 manner and expend all revenue derived from tuition and mandatory
 enrollment fees.

"(2) The governing board shall establish a process for determining
 tuition and mandatory enrollment fees. The process must provide for

participation of enrolled students and the recognized student govern ment of the university.

"(3) Before a university with a governing board authorizes, establishes or eliminates any incidental fees, the governing board shall request that the president of the university and the recognized student government transmit a joint recommendation of the change in fees to the student body and faculty.

8 "(4) In determining tuition and mandatory enrollment fees for 9 undergraduate students who are enrolled in a degree program and are 10 qualified to pay resident tuition:

"(a) The governing board may not increase the total of tuition and
 mandatory enrollment fees by more than five percent annually unless
 the board first receives approval from:

14 "(A) The Higher Education Coordinating Commission; or

15 **"(B) The Legislative Assembly.**

16 "(b) The governing board shall attempt to limit annual increases in 17 tuition and mandatory enrollment fees for undergraduate students 18 who are enrolled in a degree program and have established residency 19 in Oregon to a percentage that is not greater than the percentage in-20 crease in the Higher Education Price Index, as compiled by the 21 Commonfund Institute.

"(5) The governing board may not delegate authority to determine
tuition and mandatory enrollment fees for undergraduate students
who are enrolled in a degree program and are qualified to pay resident
tuition.

"<u>SECTION 11.</u> (1) Subject to the limitations set forth in sections 12,
15 and 19 to 23 of this 2013 Act, a university with a governing board
may:

"(a) Acquire, receive, hold, keep, pledge, control, convey, manage,
 use, lend, expend and invest all funds, appropriations, gifts, bequests,

1 stock and revenue from any source.

"(b) Subject to the limitations set forth in Article XI, section 7, of
the Oregon Constitution, borrow money for the needs of the university
in such amounts and for such time and upon such terms as may be
determined by the university or the governing board.

6 "(c) Make any and all contracts and agreements, enter into any 7 partnership, joint venture or other business arrangement and create 8 and participate fully in the operation of any business structure, in-9 cluding but not limited to the development of business structures and 10 networks with any public or private government, nonprofit or for-11 profit person or entity, that in the judgment of the university or the 12 governing board is necessary or appropriate.

"(d) Establish, collect and use charges, fines and fees for services,
 facilities, operations and programs.

"(e) Purchase, receive, subscribe for or otherwise acquire, own, hold, vote, use, sell, mortgage, lend, pledge, invest in or otherwise dispose of and deal in or with the shares, stock or other equity or interests in or obligations of any other entity. The State of Oregon may not have any proprietary or other interest in investments or funds referenced in this paragraph.

"(f) Acquire, purchase, purchase on a contractual basis, borrow,
receive, own, hold, control, convey, sell, manage, operate, lease,
lease-purchase, license, lend, invest in, issue, improve, develop, use,
expend and dispose of personal property, including intellectual property, of any nature, tangible or intangible.

"(g) Establish employee benefit plans of any type, subject to the
 university's continuing obligation to provide deferred compensation
 plans to the university's employees under ORS 351.094.

"(h) Take, hold, grant and dispose of mortgages and other security
 interests on real and personal property.

"(i) Spend all available moneys without appropriation or expendi ture limitation approval from the Legislative Assembly, except for
 moneys appropriated from the General Fund by the Legislative Assembly and the proceeds of general obligation bonds.

"(j) Acquire, purchase, purchase on a contractual basis, borrow,
receive, own, hold, control, convey, sell, manage, operate, lease,
lease-purchase, license, lend, invest in, improve, develop, use, expend
and dispose of real property.

"(k) Erect, construct, improve, remodel, develop, repair, maintain,
equip, furnish, lease, lend, convey, sell, manage, operate, use and dispose of any building, structure, land or project.

"(L) Acquire, by condemnation or otherwise, private property that
 is necessary or convenient. The right to acquire property by condem nation shall be exercised as provided by ORS chapter 35.

"(m) Establish policies for the organization, administration and
 development of the university which, to the extent set forth in those
 policies, shall have the force of law and may be enforced through
 university procedures and in any court of competent jurisdiction.

"(n) Sue in its own name, be sued in its own name and issue and
 enforce subpoenas in its own name.

"(o) Hire or retain attorneys for the provision of all legal services.
A university with a governing board shall reimburse the State Treasurer for legal fees incurred in connection with borrowings done at the
request of the university.

"(p) Purchase any and all insurance, operate a self-insurance program or otherwise arrange for the equivalent of insurance coverage of any nature and the indemnity and defense of its officers, agents and employees or other persons designated by the university.

"(q) Subject to the procedures set forth in section 8 of this 2013 Act,
 establish, supervise and control academic and other programs, units

of operation and standards, qualifications, policies and practices relating to university matters such as admissions, curriculum, grading,
student conduct, credits, scholarships and the granting of academic
degrees, certificates and other forms of recognition.

6 "(r) Enforce and recover any fees, charges and fines, including but
6 not limited to mandatory enrollment fees.

"(s) Make available and perform any and all services on such terms
as the governing board considers appropriate.

9 "(t) Delegate and provide for the further delegation of any and all 10 powers and duties, subject to the limitations expressly set forth in law. 11 "(2) The budget for a university with a governing board shall be 12 prepared in accordance with generally accepted accounting principles 13 and adopted by the governing board in accordance with ORS 192.610 14 to 192.710.

15 "(3) A governing board or university with a governing board may 16 perform any other acts that in the judgment of the board or university 17 are required, necessary or appropriate to accomplish the rights and 18 responsibilities granted to the board or university by law.

"SECTION 12. (1) Legal title to all real property acquired by a uni-19 versity with a governing board shall be taken and held in the name 20of the State of Oregon acting by and through the governing board. 21Legal title to all real property conveyed to a university with a gov-22erning board is considered to be conveyed to and vested in the State 23of Oregon, acting by and through the governing board. Authorized 24conveyances of all real property, other than university lands, acquired 25by or vested in the State of Oregon for the use or benefit of the uni-26versity must be executed in the name of the State of Oregon, acting 27by and through the governing board, by the chairperson of the gov-28erning board. 29

30 "(2) The governing board has custody and control of and shall care

for all real property used for university purposes. Management, 1 maintenance and preservation of all real property used for university $\mathbf{2}$ purposes is the responsibility of the university. Real property taken 3 and held under this section may only be encumbered by the State of 4 Oregon in accordance with state law and in a manner that would not $\mathbf{5}$ impair the financial condition of the university or the rights of the 6 holders of any obligations of the university issued or incurred under 7 any master indenture or other financing agreement. 8

9 "SECTION 13. (1) A governing board may, in its sole discretion, do
10 all of the following:

"(a) Police, control and regulate traffic and parking of vehicles on
 university property.

"(b) Establish a police department and commission one or more 13 employees as police officers in the manner and with all of the privi-14 leges and immunities set forth in ORS 352.383. When a governing board 15 establishes a police department and commissions one or more em-16 ployees as police officers, the president of the university, in cooper-17 ation with the chief of the police department, shall establish a process 18 by which the university will receive and respond to complaints in-19 volving the policies of the police department and the conduct of the 20police officers. 21

"(c) Commission special campus security officers who, when acting 22in the scope of their employment, shall have stop and frisk authority 23as set forth in ORS 131.605 to 131.625 and probable cause arrest au-24thority and the accompanying immunities as set forth in ORS 133.310 25and 133.315. Special campus security officers may not be authorized to 26carry firearms as police officers and, except as provided in subsection 27(2) of this section, may not be considered police officers for purposes 28of ORS 181.610, 238.005, 243.005 or 243.736. 29

30 "(2) A university with a governing board, acting by and through its

special campus security officers, is a criminal justice agency for pur poses of rules adopted pursuant to ORS 181.730 (3).

"SECTION 14. (1) A university with a governing board shall engage
in collective bargaining with local bargaining organizations of the
employees of the university.

6 "(2) A university with a governing board shall participate in a col-7 lective bargaining partnership with other public universities in this 8 state for the purpose of engaging in collective bargaining with existing 9 statewide bargaining organizations of the employees of the public 10 university. The collective bargaining partnership shall be established 11 by written agreement.

"(3) Subject to the authority of the Secretary of State to audit public accounts, a university with a governing board may conduct an independent audit if the governing board considers the audit advisable. Subject to ORS 297.250, the independent audit is subject to the exclusive discretion and control of the university. The independent audit is subject to disclosure pursuant to ORS 192.410 to 192.505.

"SECTION 15. (1) All moneys collected or received by a university 18 with a governing board, placed to the credit of the governing board 19 and remaining unexpended and unobligated on the date that the board 20is established, and all moneys collected or received by a university 21with a governing board after the date that the governing board is es-22tablished, may be deposited into one or more accounts established by 23the board in depositories insured by the Federal Deposit Insurance 24Corporation or the National Credit Union Share Insurance Fund. The 25governing board shall ensure that sufficient collateral secures any 26amount of funds on deposit that exceeds the limits of the coverage of 27the Federal Deposit Insurance Corporation or the National Credit Un-28ion Share Insurance Fund. All moneys in the account are continuously 29 appropriated to the governing board making the deposit for the pur-30

1 pose of carrying out the functions of the board.

"(2) Upon request of the State Treasurer, a university with a gov- $\mathbf{2}$ erning board shall enter into a written agreement with the state that 3 provides for the State Treasurer to receive, hold, keep, manage and 4 invest any amounts under the control of the university that the State $\mathbf{5}$ Treasurer determines should be held by the State Treasurer to provide 6 for payment of state borrowings and other state obligations that are 7 to be paid from moneys under the control of the university. The 8 agreement may, at the request of the State Treasurer, require the 9 university to pay the costs incurred by the State Treasurer in con-10 nection with entering into and carrying out the agreement. 11

"(3) Upon request of a university with a governing board, the State Treasurer shall enter into a written agreement with the university that provides for the State Treasurer to receive, hold, keep, manage, and invest any or all funds, appropriations, gifts, bequests, and revenue from any source in accordance with the policies and procedures established by the State Treasurer, including the recoupment of costs incurred by the State Treasurer in carrying out these tasks.

"(4) As used in this section, 'depository' has the meaning given that
 term in ORS 295.001.

21 "<u>SECTION 16.</u> (1) The following entities are not subject to any 22 provision of law enacted after January 1, 2013, that is unique to gov-23 ernmental entities unless the following entities are expressly named:

²⁴ "(a) A university with a governing board; and

25 "(b) Any not-for-profit organization or other entity if the equity of 26 the entity is owned or controlled exclusively by a university with a 27 governing board and if the organization or entity is created by the 28 university to advance any of the university's statutory missions.

"(2) Notwithstanding subsection (1) of this section, the provisions
 of ORS 30.260 to 30.460, 200.005 to 200.025, 200.045 to 200.090, 236.605 to

236.640, 279.835, 279.840, 279.850, 297.040, 307.090 and 307.112 and ORS
 chapters 35, 190, 192, 244 and 295 apply to a university with a governing
 board under the same terms as they apply to public bodies other than
 the state.

"(3) Except as otherwise provided by law, the provisions of ORS
35.550 to 35.575, 180.060, 180.210 to 180.235, 184.305 to 184.345, 190.480,
190.490, 200.035, 243.696, 357.805 to 357.895 and 656.017 (2) and ORS
chapters 182, 183, 240, 270, 273, 276, 278, 279A, 279B, 279C, 282, 283, 291,
292, 293, 294 and 297 do not apply to a university with a governing
board.

"(4) Notwithstanding subsections (1) and (3) of this section, ORS
240.167, 279C.600 to 279C.625, 279C.800, 279C.810, 279C.825, 279C.830,
279C.835, 279C.840, 279C.845, 279C.850, 279C.855, 279C.860, 279C.865,
279C.870 and 292.043 apply to a university with a governing board under
the same terms as they apply to public bodies other than the state.

"(5) Notwithstanding subsection (2) of this section, ORS 190.430 and
 192.105 do not apply to a university with a governing board or any or ganization or other entity described in subsection (1) of this section.

"(6) Except as set forth in subsection (3) of this section, ORS 243.650
 to 243.782 apply to a university with a governing board under the same
 terms as they apply to the state.

"(7) ORS 351.065, 351.067, 351.642, 351.643, 351.644, 351.646, 351.656,
351.658, 352.012 and 352.375 apply to a university with a governing
board, except that the board or university shall exercise the responsibilities and authorities of the State Board of Higher Education or the
Oregon University System.

"(8) A university with a governing board and its agents and employees remain subject to all statutes and administrative rules of this state that create rights, benefits or protections in favor of military veterans, service members and families of service members to the same extent as an agency of this state would be subject to such statutes and administrative rules.

"(9) ORS 351.692, 351.695 and 351.697 apply to a governing board, ex-3 cept that the board has the responsibilities and authorities with re-4 spect to the university it governs that the State Board of Higher $\mathbf{5}$ Education and the Oregon University System have with respect to the 6 public universities identified in ORS 351.011. A university with a gov-7 erning board may not issue a tax credit certificate under ORS 351.692, 8 351.695 and 351.697 that will cause the university to owe the General 9 Fund more than \$2.4 million at any one time under ORS 351.692, 351.695 10 and 351.697. 11

"(10) Nothing in this section may be construed so that statutory
 provisions that are not set forth in this section apply to a university
 with a governing board.

"(3) Moneys in the account are continuously appropriated to [*the Oregon University System*] **Portland State University** and may be transferred to the

"OPERATIVE DATE AND TRANSITIONAL PROVISIONS

"SECTION 168. Not later than January 1, 2014, the president of Oregon State University may notify the Governor that the university will become a university with a governing board. If a timely notification is made to the Governor by the president of Oregon State University:

"(1) Within two weeks after receiving the notification, the Governor
shall inform the President of the Senate, the Speaker of the House of
Representatives and the Legislative Counsel of the notification;

9 "(2) The Oregon State University governing board shall be estab10 lished on January 1, 2014;

"(3) Not later than January 10, 2014, Oregon State University shall
 forward recommendations for candidates for the governing board to
 the Governor for consideration; and

"(4) Not later than February 1, 2014, the Governor shall appoint the
 members of the governing board in the manner set forth in section 6
 of this 2013 Act.

"SECTION 169. (1) The State Board of Higher Education shall con-17 tinue to have jurisdiction over the operations of a university with a 18 governing board as defined in section 2 of this 2013 Act for the 2013-2014 19 academic year. However, the governing board shall propose funding 20requests pursuant to ORS 351.052, as amended by section 42 of this 2013 21Act, and shall prepare budgets, in cooperation with the Higher Edu-22cation Coordinating Commission, for the biennium beginning July 1, 232015. 24

"(2) The president of a university with a governing board shall take
over administrative responsibilities for the university from the State
Board of Higher Education on a date of the president's choosing that
is no earlier than January 1, 2014, and no later than July 1, 2014.

Nothing in this section shall affect any term or condition of any collective bargaining agreement in effect on the effective date of this 2013 Act.

"(2) All of the duties, functions, powers and lawfully incurred rights 7 and obligations of the State Board of Higher Education that pertain 8 9 to a university with a governing board are transferred to and vested in the governing board. The transfer shall include but not be limited 10 to all applicable contractual rights and obligations and title to all ap-11 plicable records, property, supplies and materials, including equip-12 ment, books and papers. For the purpose of succession to these rights 13 and obligations, the governing board is considered to be a continuation 14 of the State Board of Higher Education and not a new authority, and 15the governing board must exercise such rights and fulfill such obli-16 gations as if they had not been assigned or transferred, except as 17 otherwise provided by law. 18

"(3) All unexpended moneys, including but not limited to General Fund appropriations, gifts, bequests, other funds, assessments, liability and worker's compensation reserves and premiums that are appropriated to, held, managed or invested by or on behalf of or otherwise available to a university with a governing board, are appropriated and transferred to the university.

"(4) A university with a governing board shall conduct and complete
any proceeding, action, prosecution or other matter that the university commenced before the effective date of this 2013 Act and that is
pending on the effective date of this 2013 Act.

"(5) The transfer of duties, functions and powers to a governing
 board or university with a governing board does not affect any action,

suit or proceeding relating to the university, except that the university
shall be substituted for the State Board of Higher Education and the
State of Oregon in any such action, suit or proceeding.

4 "(6) Any action, proceeding or other matter that was commenced 5 by a state agency, a state officer, the State Board of Higher Education 6 or an officer or employee of the State Board of Higher Education be-7 fore the effective date of this 2013 Act and relates to the governing 8 board or university with a governing board and is still pending on the 9 effective date of this 2013 Act shall be conducted and completed by the 10 governing board or university.

"(7) Nothing in this 2013 Act relieves any person, public entity or private entity of any obligation with respect to a tax, fee, fine or other charge, interest, penalty, forfeiture, rule, policy, document, record or proceeding.

"(8) Notwithstanding any other provision of this section, the law-15fully adopted rules and policies of the State Board of Higher Education 16 pertaining to a university with a governing board that are in effect 17 on the effective date of this 2013 Act continue in effect until lawfully 18 superseded or repealed by the rules or policies of the governing board 19 or the university. References in rules or policies of the State Board 20of Higher Education to the state board or an officer or employee of the 21state board are considered to be references to the governing board or 22an officer or employee of a university with a governing board. 23

"SECTION 171. Sections 1 to 23, 164, 165, 169 and 170 of this 2013 Act,
the amendments to statutes and session laws by sections 24, 25, 28 to
37 and 40 to 162 of this 2013 Act and the repeal of statutes by section
163 of this 2013 Act become operative on January 1, 2014.

"<u>SECTION 172.</u> (1) The State Board of Higher Education and a uni versity with a governing board as defined in section 2 of this 2013 Act
 may take any action before the operative date specified in section 171

of this 2013 Act that is necessary for the State Board of Higher Education and the university to exercise, on and after the operative date specified in section 171 of this 2013 Act, all of the duties, functions and powers conferred on the State Board of Higher Education and university by this 2013 Act.

6 "(2) Before the operative date specified in section 171 of this 2013 7 Act, the president of Oregon State University may inform the Gover-8 nor of the university's decision to establish a governing board in the 9 manner set forth in section 168 of this 2013 Act.

"(3) If Oregon State University notifies the Governor of the
 university's decision to establish a governing board before January 1,
 2014, the Governor may appoint members to the governing board be fore the operative date specified in section 171 of this 2013 Act.
